- Loan of the audio-visual media to dedicated teachers for use within lessons.

The undersigned also agrees that Schweizer Tanzarchiv makes the works available for Swiss technical colleges and universities working in the area of dance training and research and who cooperate with Schweizer Tanzarchiv.
